- 2.1 To approve an internal inspection of the accounts April 2013 to March 2014
  The 1965 Industrial and Provident Societies Act requires THGI Ltd to have its annual accounts externally audited every year. This could cost about £800. However the Friendly and Industrial and Provident Societies Act 1968 gives THGI Ltd the option for the Members at the AGM to vote for not having the annual accounts externally audited. Instead the accounts can be internally inspected and signed off as being correct by the Secretary and two Directors, before being presented to the AGM for Members' approval. (A similar AGM vote will have to take place in future years to approve any future internal inspection of the financial accounts).

  Resolution 2: The Management Committee of Directors recommends the Members vote in favour of approving the internal inspection of the accounts April 2013 to March 2014 only.

## 2.2 Appointment of auditors (if required)

Resolution 3: The Management Committee of Directors recommends the Members vote **not** to have an external audit of the accounts April 2013 to March 2014.
