The Annual General Meeting of Exeter Street Community Hall Limited, will be held on **Wednesday 5**th **June**, **2024** at 7:30pm at Exeter Street Hall.

We hope to include a presentation on the work of one of the Hall's regular hirers, the **Grace Eyre Foundation.** A representative will talk about how Grace Eyre supports people with a learning disability and autism and what they do during the two days a week when they are in the Hall.

After the AGM there will be a social event. The bar will be opened and Members can exchange their voting card for a <u>free drink</u>.

You have been invited to the AGM because you are a Member (= shareholder) of **Exeter Street Community Hall Ltd (ESCH)**, the society that runs Exeter Street Hall.

ESCH is a community benefit society registered with the Financial Conduct Authority under the Cooperative and Community Benefit Societies Act 2014 (registration no. 8161) and recognised as charitable by HMRC (reference no. ZD03543).

Only Members may vote and each Member has one vote irrespective of the number of shares held. We need 5% of Members (equivalent to 45 people, including proxy voters) for the quorum.

There will be five items to be voted on by Members:

1. Last year's Minutes

The Directors recommend that Members vote to approve the minutes of the 2023 AGM.

2. The Directors' Report

The Directors' Report will be presented at the AGM with time set aside to answer questions.

The Directors recommend that Members vote to approve the Directors' Report.

3. Financial Report for April 2023 to March 2024

The Financial Report will be presented at the AGM with time set aside to answer questions.

The Directors recommend that Members vote to approve the Financial Report.

4. Appointment of Auditors (if required).

The Co-operative and Community Benefit Societies Act 2014 allows smaller societies like ours to avoid the expense of an external audit of accounts for the current financial year. To do this, each year Members must approve a resolution <u>not</u> to appoint auditors for the current financial year by a large (80%) majority. The accounts may then be signed off by the Secretary and two members of the Management Committee.

Our Treasurer is a qualified, practising accountant. We are confident that our accounts are accurate and that they comply with legal requirements.

The Directors recommend that Members vote <u>not</u> to have an external audit for the April 2024 - March 2025 accounts.

5. Election of the Directors of Exeter Street Community Hall Ltd.

ESCH rules (see <u>exeterstreethall.org/our-rules</u>) state that one third of Directors (or the nearest number to one third), in order of longest serving, must stand down each year. They can be re-elected.

New Management Committee members

The Committee primarily sets policies and oversees expenditure, though its agendas cover a great variety of topics, large and small. It normally meets monthly and between meetings communicates by email, phone and personal contact. If you would like to know what is involved or to suggest someone please contact any of the current members or email the ESCH Secretary (address below). Directors must be elected at the AGM but Management Committee members may be co-opted in between AGMs, so you could come along to a couple of meetings and then decide if you'd like to stay.

Any Other Business?

Members can of course ask questions on the day, but if you know you would like to have something discussed at the AGM under Any Other Business please send a short email, including your name and contact details, to the ESCH Secretary or deliver/post a message to the Hall, to arrive by Monday 3rd June.

Proxy Voting

If you cannot attend the meeting you may nominate either the Chair of the meeting or another Member to attend as your proxy and vote on your behalf. Please do so if you know you can't come to the meeting, as proxy votes can help to ensure the AGM is quorate.

If you would like to vote in this way please fill in the <u>proxy voting form</u> and return it to the ESCH Secretary.

- If you nominate the Chair of the meeting as your proxy the Secretary will count your votes and pass them on to the Chair, who will add the proxy votes to the totals.
- If you nominate another member as your proxy the Secretary will check the name of this Member and give them an extra voting card at the meeting.

You do not have to sign the form and scan it if you want to send in the form electronically. Simply email the completed form by Monday 3rd June to the ESCH Secretary. Or, if you prefer, you can print the proxy form and deliver/post it to the Hall.

Submitted forms will be checked against the attendance register to ensure that there is no duplicate voting. Exeter Street Hall shareholders are by and large very honest people but we are required to take all reasonable steps to ensure accurate voting results. The proxy voting form and related information will be available on the AGM web page (see above for the address) by Saturday 18th May.
